

Whether the rates shall be quoted as per minimum wages as mentioned in Tender document or will quoted as declared by Govt. before Imposition of Code of Conduct for General Election.				It was clarified that all the bidders shall considering minimum Wages as mentioned in Tender document i.e <b>Unskilled Worker: Rs.352/-</b> <b>Semiskilled Worker- Rs.392/-</b> <b>Skilled Worker-Rs.442/-</b> <b>Skilled Worker-Rs.502/-</b> However, it is mentioned that as and when the Minimum wages increased Notification released by Govt. of Odisha, the rates shall be revised accordingly.			
At point no. 16, page no 6 it was mentioned that <b>Rs. 10,000,00/-towards</b> deposit of Security money for " <b>Milk &amp; Milk Products and Miscellaneous Works</b> ". Which seems too high for which it needs to be minimize the security money looking to the persons involved				The Committee observed last three months Invoice value and found that one-month invoice value is coming more than <b>Rs. 15.00 Lakhs</b> towards " <b>Milk &amp; Milk Products and Miscellaneous Works</b> ". Therefore, the Committee decided to keep the <b>Security money of Rs.15.00 Lakhs (Fifteen Lakhs only)</b> towards " <b>Milk &amp; Milk Products and Miscellaneous Works</b> " at Omfed Dairy, Arilo.			
Whether rates shall be quoted considering all cost as mentioned in <b>Scheduled –II, point no. 05 at page no.05i.e</b> "As a safety measure, the Contractor has to provide safety shoe, uniform for the workers of Job Contract. The Contractor has to provide the said material within 02 months from the date of issue of work order and in every 18 months. Uniform code will be finalized by Plant Manager"				<b>The rates shall be quoted excluding the rates of items as mentioned at point no. 05.</b>  Accordingly, all the bidders have to quote the rates and L1 bidder will be finalized.
