SECTION II

INSTRUCTION TO BIDDERS -:

1.0 GENERAL INFORMATION:

The bidders shall to go through the terms and conditions and instructions mentioned herein carefully and visit the site for an actual assessment prior to submitting the bids.

The **Two-Parttender** document consists of

Part-A: Pre qualifying technical bid.

Part-B: Commercial bid with quoted price schedule.

Bidders are to be submitted TWO PART. Both Part-A, Technical bid & Part-B Commercial Bid should be in separate envelope.

A pre-bid meeting shall be conducted on dt.24/01/2023, 11:00AM. Bidders requested to participate in the pre-bid meeting for any clarification regarding bidding document.

DOCUMENTS TO BE SUBMITTED IN THE TECHNICAL BID(PART-A):

- Audited profit & loss account statement for the year 2019-20, 2020-21, 2021-22 (Three years).
- Turn over for the financial year 2019-20, 2020-21, 2021-22 (Three years).

- Credentials in support of installation & commissioning of said machineries during last five years.
- Documentary evidence to be established in accordance with Clause 9 that the bidder is eligible to bid and is qualified to perform the contract if its bid is accepted.

Period of Completion

For positioning, installation, commissioning & trial run of equipments:

The Plant Manager of respective dairies shall notify the contractor for start of the work after completion of the civil foundation work. The work should be completed within three months from the date of issuance of notice to the contractor for start of the work.

1.4 <u>IMPORTANT NOTE</u>

Period of completion of work is very vital for this project. Time is the essence of contract and the work has to be carried out strictly as per the scheduled work program.

2.0 Eligibility and Qualification requirements: -

- 2.1 The bidder should have minimum Threeyears' experience in the related field likeinstallation/Erection & commissioning of dairy equipment's.
- 2.2 Annual Sales turn over should not to be less than 3lakhs during the financial year, 2019-2020,2020-2021, 2021-2022.
- 2.3 The bidder shall furnish documents in accordance to clause no.9 for establishing eligibility

3.0 Price basis:

3.1 For erection/installation, testing, commissioning, trial run &handing over:

Bidders shall submit separate rates for complete installation, testing and commissioning, including satisfactory performance trial run for 30 days.

Prices quoted towards erection, testing & commissioning of Dairy Equipment should be inclusive of all taxes & duties, insurance and other incidental charges as applicable

4.0 Cost of Bidding

The Bidder shall bear all costs associated with the preparation and submission of its bid, and the Orissa State Cooperative Milk Producers' Federation Limited, hereinafter referred to as "THE OMFED", will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

B. THE BIDDING DOCUMENTS

5.0 CONTENT OF BIDDING DOCUMENTS

- 5.1 The goods required, bidding procedures and contract terms are prescribed in the bidding documents. In addition to the tender notice, the bidding documents include:
 - (a) Instruction to bidders:
 - (b) General Conditions of Contract;
 - (c) Schedule of quantities;
 - (d) Bid Form;
 - (e) Form of agreement
 - (f) Standard Forms of Bank Guarantees;
- 5.2 The Bidder is expected to examine all instructions, forms, terms and specifications in the bidding documents. Failure to furnish all information required by the bidding documents

or submission of a bid not substantially responsive to the bidding documents in every respect will be at the bidder's risk and may result in the rejection of its bid.

6.0 Amendment of Bidding Documents

- 6.1 At any time prior to the deadline for submission of bids, the OMFED may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the Bidding Documents by amendment.
- 6.2 The amendment will be notified in the website to all prospective Bidders. The amendment should be attached to the bidding documents.
- 6.3 In order to afford prospective Bidders reasonable time in which to take the amendment into account in preparing their bids, the OMFED may, at its discretion, extend the deadline for the submission of bids.

7.0 Bid form

The Bidder shall complete the bid Form and the schedule of quantities furnished in the Bidding Documents, indicating for the goods to be supplied, a brief description of the goods, quantity and prices.

8.0 Bid Prices

- 8.1 The bidder shall indicate in the schedule of quantities, provided in this document, the unit prices and total Bid prices of Dairy Equipment to be installed, commissioned under the Contract, inclusive of all taxes & duties, packing &forwardingcharges, transportation, insurance and other incidental charges, loading & unloading chargesetc for the pipelines & fittings required for installation & commissioning of the Dairy Equipment.
- 8.2 Bidders are requested to visit the site for an actual assessment prior to submitting the bids.
- 8.3 It is mandatory on the part of the bidders to quote separately for all dairies for positioning, erection, commissioning & trial run of the equipment's.

9.0 <u>Documents Establishing Bidders' Eligibility and Qualifications</u>

- 9.1 The Bidder shall furnish, as part of its bid, documents establishing the bidder's eligibility to bid and its qualifications to perform the contract if its bid is accepted. The bidder should also give information in the format attached to the Bid document.
- 9.2 The documentary evidence of the Bidder's qualification to perform the contract if its bid is accepted, shall establish to the OMFED'S satisfaction:
 - i) That the bidder has the financial, technical and production capability necessary to perform the contract.
 - ii) Copies of original documents defining the constitution or legal status, place of registration and principal place of business of the company or firm or partnership etc.
 - iii) Details of experience and past performance of the bidder on equipment offered and on those of similar nature within the past 3 years and details of current contracts in hand and other commitments;
 - iv) Major items of plant and equipment's installed at the client's factory premises;
 - v) Qualification and experience of key personnel for successful execution of the contract;

- vi) Reports on financial standing of the bidder such as profit and loss statements, balance sheets and auditor's report of the past three years, bankers certificates etc;
- vii)Detail Information regarding any current litigation in which the bidder is involved.

10.0 Earnest Money Deposit

- 10.1 The Bidder shall furnish, as part of its bid, EMD of Rs. 20,000/-.
- The bid security is required to protect the OMFED against the risk of bidder's conduct, which would warrant the security's forfeiture, pursuant to para.10.7.
- 10.3 The bid security shall be in one of the following forms:
- (a) A Bank guarantee issued by a Nationalized bank located in India in the form provided in the Bidding Documents, and valid for 30 days beyond the validity of the bid, or
- (b) A demand draft in favor of ORISSA STATE CO-OPERATIVE MILK PRODUCERS' FEDERATION LTD., Payable at Bhubaneswar.
- 10.4 Any bid not secured in accordance with Para's. 10.1 and 10.3 shall be rejected by the OMFED as non-responsive.
- 10.5 Unsuccessful bidder's bid security will be discharged/returned as promptly as possible but not later than 30 days after the expiration of the period of bid validity.
- 10.6 The successful Bidder's bid security will be discharged upon the bidders executing the agreement.
- 10.7 The bid security may be forfeited:
- (a) If a bidder withdraws its bid during the period of bid validity specified by the bidder on the bid form; or
- (b) In the case of successful bidder, if the bidder fails to sign the contract.

11.0 Period of validity of bids

11.1 Bids shall remain valid for <u>120 days</u> from the date of bid opening, stated in the cover page/ tender notice. A bid valid for a shorter period may be rejected by the OMFED as non-responsive.

12.0 Signing of Agreement

Within 15 days of receipt of the notification of award of contract, the successful bidder shall prepare & sign the agreement, in the format provided in this bidding document, and

send the same to the OMFED along with a duplicate copy. The original contract form shall be retained by the OMFED, & a duplicate copy of the same shall be sent to the contractor, after it has been signed and dated.

13.0 <u>Performance Security Deposit</u>

- 13.1 Within 15 days of receipt of the notification of award of contract from the OMFED, the successful bidder shall furnish the performance security deposit of Rs.50,000.00/- (Rupees Fifty Thousand only) (for positioning, erection, commissioning & trial run work), either in the form of a Bank guarantee valid for six months from the date of award of contract (as per the performance security form provided in the bidding document) or in the form of demand draft drawn in favor of OMFED, payable at Bhubaneswar.
- 13.2 The performance security deposit (PSD) shall be refunded after three months of completion of work without bearing any interest thereon.
- 13.3 The PSD shall be forfeited in case the bidder fails to complete the obligation andleavethe work in midway.

SECTION -III.

GENERAL CONDITIONS OF CONTRACT

1. <u>Terms of payment</u>

1.1 For positioning, installation, commissioning & trial run of equipments.

90% payment after successful completion of positioning, installation, commissioning & trial run of equipment's at respective Dairies. The bidder has to raise invoice Dairy wise and payment shall be made dairy wise for erection, commissioning & trial run of the Dairy Equipment wherever applicable as per tender on receipt of completion certificate from the respective Plant Manager.

Retention Money

10% of the bill value raised for individual dairies shall be retained by OMFED and shall be released on satisfactory completion of the work at all Dairies after duly certified by respective Plant Managers of all Dairies.

NOTES-:

- i) For all the payments to be made against Bank guarantees, the bank guarantee shall be issued by a nationalized bank located in India.
- 1.2The contractor's request(s) for payment shall be made to the Managing Director, OMFED in writing, accompanied by an invoice describing, as appropriate, the goods delivered and services performed, and by shipping documents and upon fulfillment of other obligations stipulated in the contract.

2. Time for completion

Subject to any requirement in the contract as to completion of any section of the works before completion of the whole, the whole of the works shall be completed, within the time period stated in section–II of the bidding documents.

2.1 Penalty for Delay

If the contractor shall fail to achieve completion of the works within the specified time, then the contractor shall pay to the OMFED the sum at the rate of 0.5 % (half percent) of the total value of work done under the contract, as a penalty, for every week or part of the week which shall elapse, between the time prescribed & the date of certified completion of the work. The OMFED may without prejudice to any other method of recovery, deduct the amount of such penalty from any payment in its hands, due or which may become due to the contractor. The payment or deduction of such penalty shall not relieve the contractor from obligations to complete the works, or from any other of his obligations and liabilities under the contract.

- 2.2 The aggregate maximum of the penalty for delay payable to the OMFED under this clause shall be subject to a maximum of 5 % of the total value of work.
- 2.3 The criteria for deriving the penalty for delay shall be the actual value of works executed and the amended time of completion.
- 2.4 Any incremental taxes and levies due to the delay in the performance of the contract by the contractor shall be to the contractor's account.

3. <u>Termination for Insolvency</u>

The OMFED may at any time terminate the contract by giving written notice to the contractor, without compensation to the contractor, if:

- (a) The contractor becomes bankrupt or otherwise insolvent,
- (b) The contractor being a company is wound up voluntarily by the order of a court receiver, liquidator or manager appointed on behalf of the debenture holders or circumstances shall have arisen which entitle the court or debenture holders to appoint a receiver, liquidator or a manager,

Provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the OMFED.

4. **Arbitration**

All disputes or differences in respect of which the decision is not final and conclusive shall, on the initiative of either party, be referred for adjudication as per the Arbitration and Conciliation Act 1996

4.1 Applicable law

The contract shall be interpreted in accordance with the laws of the union of India.

4.2 <u>Taxes and Duties</u>

- (i)The contractor shall be entirely responsible for all taxes, duties, license fees etc. incurred until handing over of the contractor goods and services to the OMFED. All Government fees paid for inspections and approvals by statutory authorities shall be reimbursed by the OMFED on production of copy of treasury Challan for same. Service charges for depositing the govt. fees or submission of requisite forms with the statutory authorities shall be not being admissible
- (ii) The Contractor shall be liable to pay all Corporate taxes, income tax and other taxes that shall be levied according to the laws and regulations applicable from time to time in India.

(iii) The Contractor shall accept full and exclusive liabilities under the ESI, EPF, Compensation for accidents or injury, Compensation paid to Workman, security charges if any etc.

5.0 Jurisdiction

For the settlement of any dispute arising out of the contract against this bid, only the courts at Bhubaneswar shall have jurisdiction.

6.0 Statutory Provisions of ESI & EPF for resource engaged:

The vendor must abide by all applicable rules, laws ®ulations that may be in force from time to time and shall be responsible for conduct of resource persons as animmediate Employer. Further, the vendor shall ensure compliance of all permissionsunder Act & Regulations of ESI & EPF Scheme. Vender should submit the relevantrecords & registers towards contribution made for ESI & EPF in respect of the resourcepersons engaged as when required by the concerned Statutory Authorities. If thevendor defaults in any manner to comply with the provisions of ESI & EPF Act &Scheme made there under including all other applicable Laws & Regulations, the vendorshall be solely responsible for the same and shall be liable to pay anyfine/penalty/damage/interest imposed by the authorities. In case of default by the vendorthe notional amount towards fine/penalty/damage/interest likely to be imposed by theconcerned Statutory **Authorities** shall be deducted from Bill/SecurityDeposit/Performance Guarantee and kept separately till finalization of the matter. Nointerest shall be paid on such amount.

Besides the above, the vendor requires complying with any other Act/Provisions such aspayment of Bonus etc., if applicable for the resource persons engaged.

- **2.**Total quoted cost shall be inclusive of positioning of equipment, installation, connection of electrification/cable from panel board to machine, commissioning, trial run of the said equipment's inclusive of all taxes etc. Separate format is not acceptable at all.
- **3**. The MS/GI/SS pipelines, fittings, insulation etc required for the commissioning & trial run of the equipment is in the scope of bidder.
- **4.**The length of required pipe lines, cables etc may be considered 75mtr for individual Dairies towards submission of bid. Bidder may take back excess material if any after issuance of gate pass against the said material by Plant Manager of respective Dairies. Payment shall be made on actual length of the Pipelines. Joint measurement to be taken by the bidder and representatives of Plant Manager. Rates will be considered as quoted in Annexure-I. HMI & instrumentation if not working and confirmed by Plant Manager of respective Dairies then it will be repaired by OMFED. Looking into the down time for such repairs, the completion period can be extended after getting approval from the competent authority.
- **5.** The bidders shall submit the unit rate of pipe lines, cables, insulation etc provided at the Annexure-I. If the bidder feels the requirement of any other item not mentioned in the list may provide the unit rate in separate sheet.
- **6.** Supply of required spare parts is in the scope of OMFED.
- **7.**HMI & instrumentation if not working & confirmed by Plant Manager of the respective dairies then it will be repaired by OMFED.
- 8. At the time of installation or erection & commissioning, if any material gets damage or broken, will be bear by contractor.
